

Exam Results

Some Vocational qualification results issue shortly after we have made the claim, for others result dates are fixed. **Where no fixed date applies, your results will display on eilp, and you will receive your qualification certificate through the post.**

Where fixed results dates apply, you can collect your statement of results from 9.15am on campus. **Look out for an invitation from us w/c 7th August containing result day information and collection points.** Remember to bring ID.

Any uncollected statement of results will be posted to you later on results day.

If you cannot collect your results yourself, you will need to give authorisation in writing (not text or email) to allow someone else to collect for you. No results can be given over the phone or email, in any circumstance. Results will also become available via eilp on results day.

Guide to Post Result Services – Summer 2023

Post result services can only be accessed via the College. If you wish to access these services, you must speak to a member of the exams team to apply. You will be given a consent form, which enables the College to submit your request for a post results service.

IMPORTANT – both marks and overall subject grades could go down as well as up, discuss with staff before deciding to make an application.

Holding a University place? Awarding bodies strongly advise candidates to inform their university or college choices that a review of results has been requested. By informing them, they may be able to keep the candidate's place open until the review has been completed. An awarding body will not inform UCAS or others that a review of marking has been requested.

Service 1 - Clerical Re check This service will include the following checks: • that all parts of the script have been marked; • the totalling of marks; • the recording of marks.

Service 2 – Review of Marking This is a post-results review of the original marking to ensure that the mark scheme has been applied correctly. A marking error can occur because of: • an administrative error; • a failure to apply the mark scheme where a task has only a 'right' or 'wrong' answer; • an unreasonable exercise of academic judgement. The awarding body will train its reviewers to conduct reviews of marking accurately and consistently. **Reviewers will not re-mark the script. They will only act to correct any errors identified in the original marking.**
